- New Business:Approval of Start College Now Requests: Matt Olson, School Counselor explained the
process for students requesting dual enrollment through the Start College Now program.
WVL will pay for 18 credits per student enrolled in the program. Dual enrollment
applications are presented to the board for approval in March for the fall semester and
in October for the spring semester.

D. LaPointe made a motion to approve the Start College Now requests as outlined, not to exceed 18 credits per student, seconded by E. Dimmitt. *Motion carried unanimously.*
